THESE CHILDREN RECEIVE THREE MEALS A DAY, SCHOOL SUPPLIES, MEDICAL CARE, AND SPIRITUAL DISCIPLESHIP. THEY LEARN ABOUT JESUS IN SCHOOL, AND PERIODICALLY ALL THE SPONSORED CHILDREN COME TO THE ORGANIZATION FELLOWSHIP SITE FOR BIBLE STUDY, WORSHIP, LUNCH, AND PLAYING.
